**Pulse of Australia Survey Competition**

1. Information on how to enter form part of these conditions. Entry into the competition constitutes acceptance of these terms and conditions.
2. Entry is only open to all residents of Australia.
3. Various promotions will be conducted under these terms and conditions during the period commencing 12:01am, Saturday 20 October, 2018 and ending 23:59, Monday 30 September, 2019. All times refer to Australian Eastern Standard or Daylight Time whichever is relevant at the time unless otherwise stated.
